## MVBOC MEMBERSHIP CLASSIFICATION

**ACTIVE MEMBERSHIP:** The Board may grant an Active Membership to governmental jurisdictions, boards or committees and to persons directly or contractually employed in governmental departments, boards or committees who administer, develop, apply, interpret, formulate laws, ordinances or regulations pertaining to building, zoning or housing, enforce codes for or on the behalf of a governmental or regulatory body. Governmental departments and boards of committees applying for this classification of membership shall designate an individual(s) who meets these qualifications, as its representative. Members shall receive a certificate signed and dated with issuance or expiration, by the Secretary of the organization identifying his/her approved classification. Members in this classification may attend meetings, serve on committees, be elected to the governing body, have educational and voting benefits, and other benefits the Board may grant.

**RETIRED ACTIVE MEMBERSHIP:** The Board may grant Retired Active Membership to an individual who previously qualified for Active Membership, but, has retired from his/her employment. Members shall receive a certificate signed and dated with issuance or expiration, by the Secretary of the organization identifying his/her approved classification. Members in this classification may attend meetings, serve on committees, have educational and voting benefits, and other benefits the Board may grant from time to time, but shall not be eligible for election to the governing body of the organization.

**ASSOCIATE MEMBERSHIP:** The Board may grant an Associate Membership to those individuals who are directly or indirectly affected by the building code, national or regional organizations, manufacturers of building materials, design professionals, contractors, and individuals with other similar interests and concerns with the construction and building industry but, do not qualify for Active Membership. Members shall receive a certificate signed and dated with issuance or expiration, by the Secretary of the organization identifying his/her approved classification. Members in this classification may attend regular meetings, serve on committees, and educational benefits, but shall not be eligible for election to the governing body or vote.

**HONORARY (LIFE) MEMBERSHIP:** As an award for an individual who has consistently, throughout the years, rendered meritorious service in the furtherance of the objectives of this organization, MVBOC may award an individual the additional classification (of his/her above qualifications and membership) with a special award of an Honorary (Life) Member. Upon recommendation of the Board, Honorary Membership shall be conferred upon an individual by majority vote of the Active Membership present at any regular meeting of the organization. An award presentation and a Resolution by the Board may be made at the Annual Business Meeting in December, in recognition of this individual's valued service to the MVBOC organization.
